GENERAL INFORMATION, RULES & REGULATIONS

1. **QUALIFICATIONS:** Eligibility is limited to persons or firms who manufacture, remanufacture or supply products, tools, equipment, supplies or services used by the automotive recycling industry.
2. **APPLICATION:** All potential exhibitors must file a written contract. Telephone orders are not accepted.
3. **CHANGES IN THE BOOTH FLOOR PLAN:** Nebraska Tow Show reserves the right to change the booth floor plan and booth locations. Nebraska Tow Show will respect choice of booth space so far as possible. Where space requested is not available, space will be assigned to conform as nearly as possible in size and location as requested.
4. **VALIDITY:** No contract is valid until the application and all monies are submitted to Nebraska Tow Show.
5. **DUE DILIGENCE:** Nebraska Tow Show makes no representation concerning any sponsor or exhibitor nor its products or services and the admission to the show of any sponsor or exhibitor constitutes neither an endorsement, recommendation nor representation by Nebraska Tow Show of any exhibitor or sponsor or its products or services. Nebraska Tow Show has not and will not undertake or perform any due diligence function as to any sponsor or its products or services and each exhibitor or sponsor agrees to display only services and products which have economic viability and that fully comply with applicable law, regulations and professional standards.
6. Exhibitors agree to comply with all rules and regulations of the owner of the exhibit hall.
7. **TERMS OF PAYMENT:** 50% deposit is due with signed contract. Final payment for the booth is due by May 1, 2019. No exhibit or part of an exhibit will be admitted to any space until the rental for the space has been paid in full.
8. **REFUNDS:** 50% refund on written cancellations received in the Nebraska Tow Show Office before May 1, 2019. No refund for cancellation received in the Nebraska Tow Show Office after May 1, 2019.
9. **SPACE ASSIGNMENT:** All booths must be open and occupied during the display times of the Exposition. Space assignments will be made in the order applications are received. Exhibitors should select three different booths or groups of booths in separate locations and specify the order of their choice. If none of these are available Nebraska Tow Show will assign space subject to Exhibitor's approval.
10. **SUBLETTING OF SPACE: NO SPACE SHALL BE SUBLET WITHOUT THE EXPRESS WRITTEN CONSENT OF THE NEBRASKA TOW SHOW. ONLY ONE COMPANY MAY CONTRACT FOR EXHIBIT SPACE.**
11. **EXHIBIT PERSONNEL:** All personnel working in an exhibitor's booth or space must be a registrant. The person's and company's name must be on the badge and the badge must be visible at all times.
12. **DISPLAY OF PRODUCTS:** Display of products on the floor will be confined horizontally and vertically by firms occupying within contracted space who are a part of the exposition. An additional space fee will be charged on any display extending beyond or above contracted space. No exhibitor shall exhibit or permit to be exhibited in the space leased by him/her any services or products not sold by him/her on a regular basis.
13. **EXHIBITOR AGREEMENT: No use of microphones, loudspeakers, or other amplifying public address devices, without consent of the Nebraska Tow Show; all displays, interviews, conferences, distribution of literature, lectures and cash sales will be made within the confines of leased booth space. Any conferences, meetings, solicitation of business or canvassing in leased space are not permitted except in the interest of the Corporation, Company, or Individual whose name appears on the firm name sign. All signs will be limited to 8 feet in height, and all displays requesting more than 8 feet in height must secure approval from the Nebraska Tow Show.**
14. **HOURS OF EXHIBITS:** The exhibit hall will be open 8:00 a.m.- 4:00 p.m., June 1, 2019.
15. **EXHIBIT LIGHT AND POWER:** The exhibit hall will be adequately lighted. Electrical is \$25.00.
16. **SAFE DECORATIONS:** All decorations must be flame-proof and pass inspection by all legal authorizes. All battery cables to vehicle batteries must be disconnected and all vehicle gas caps must be taped.
17. **INSURANCE:** It is directly understood and agreed to that in no case shall Nebraska Tow Show, its officers or agents be responsible for any loss, theft, damage by fire, or injury of any character to any person or article. Security will be provided, but Nebraska Tow Show, while taking all precautions against this, will not guarantee against it. Exhibitors wishing to insure their goods must do so at their own expense.
18. **INTOXICANTS:** Exhibitor expressly agrees not to serve, sell or give away any intoxicants at or near the booth, and the violation of this agreement shall entitle Nebraska Tow Show to close the exhibit and remove and store same in the manner provided in paragraph 27.
19. **IMPROVEMENTS:** Any additions or improvements to space other than standard equipment shall be at the exhibitor's expense, subject to approval by Nebraska Tow Show.
20. **EXHIBITOR FURNITURE & ACCESSORIES:** Nebraska Tow Show provide a skirted table and two chairs for each exhibit.
21. **INSTALLATION SERVICES:** Space will be ready for installation of exhibits 12:00 p.m., Friday, May 31, 2019. Installations must be completed by 5:00 p.m., Friday, May 31, 2019 or shall be deemed open after this time, unless permission for waiver is received from Nebraska Tow Show due to an emergency.
22. **UNCRATING, ERECTION AND DISMANTLING OF EXHIBITS:** You will be responsible for your own display.
23. **SHIPPING INSTRUCTIONS:** Please do not ship displays any sooner than the week of May 29-June 1, 2018. The freight company handing the show is TLK Freight in Omaha. Please contact Dana Adamy at 402/890-6531 for shipping information.
24. **REMOVAL OF EXHIBITS:** Exhibitors will not be permitted to remove exhibits or any part of same until 4:00 p.m., Saturday, June 1, 2019.
25. **MOVING IN AND OUT:** Failure to remove an exhibit in the allowed time will give Nebraska Tow Show the right to remove and place in a warehouse, subject to the exhibitor's disposition; its payment of all charges and no liability to Nebraska Tow Show. All exhibits must remain intact until the convention is closed.
26. **RIGHTS OF Nebraska Tow Show IN EVENT EXPOSITION IS NOT HELD:** Should any emergency arise previous to opening the Exposition which would prevent its scheduled opening, such as destruction or damage to the facility by fire, windstorm strikes or acts of God, etc., or declaration of emergency by the President, it is expressly understood and agreed that Nebraska Tow Show may retain as much of the payment for an exhibit as is necessary to cover the expenses incurred up to the time of such emergency.
27. Exhibitor agrees to comply with all applicable federal, state, and local laws.
28. **LICENSE FEES & ROYALTIES:** Exhibitor agrees to pay when due all royalties, license fees or other charges accruing or becoming due to any firm, person or corporation by reason of any music, either live or recorded, or other entertainment of any kind of nature, played, staged or produced by the Exhibitor, its agents, employees or subtenants within the premises covered by this License Agreement including but not limited to, royalties or licensing fees due to BMI, ASCAP, or SESAC. Exhibitor agrees to hold harmless Nebraska Tow Show, its agents and employees against any and all such claims and charges, and to defend, at its own expense, any and all such claims and charges. Exhibitor shall have the right, however, to protest and if desired, to litigate and adjudicate any and all such claims.
